The "E" Award was for Excellence in Production during WW II. Only 5% of U.S. Companies had earned this prestigious flag by the war's end. Additional "E" Awards provided a Silver Star to the flag and could be earned at 6-month intervals. Collins Radio Company was one of a very few to have earned five stars on their "E" Flag - the last awarded on August 28, 1945.

AACLA Purpose

This report documents the Fiscal Year 2017 activities and accomplishments of the AACLA for donors and volunteers. This is a yearly summary and additional details can be obtained by contacting one of the officers. The AACLA was incorporated in the State of Iowa on January 3, 2014 and became a 501(c)(3) non-profit organization in October 2014.

The purpose of the AACLA is to preserve, honor, and interpret the legacy and memory of Arthur A. Collins and the significant contributions he and Collins Radio Co. made in the world of communications, aerospace and defense technologies. The AACLA is organized for the purpose of promoting education in Science, Technology, Engineering, and Mathematics (STEM). The organization works to inspire and teach future generations by the preservation, interpretation and display of artifacts, conducting educational events, exploring grants and other funding opportunities which may ultimately lead to the creation and operation of a heritage learning center in Cedar Rapids, Iowa.

AACLA Personnel

The organization consists of a board of directors (who elect the officers) and a cadre of volunteers. The board meets monthly with its annual meeting in November. During the year Phil White resigned from the board due to increased commitments elsewhere. AACLA Projects

AACLA Projects fall into six broad categories. A summary of Fiscal Year 2017 activities of each follows:

1. Collins Historical Documentaries

- Hired a professional media consultant, Busbee Communications, to coordinate and conduct interviews for Collins Historical Documentaries. Also hired a person to transcribe the video interviews (needed for editing into a finished documentary).
- Conducted interviews with 13 Collins Retirees in the Dallas, Texas area in Dec. 2016 and early 2017.
- Conducted interviews with 19 Collins Retirees at Cottage Grove Place, Cedar Rapids, lowa in June 2017 plus 3 additional in Cedar Rapids
- Detailed Planning for production of a Space Communications Documentary
- Continued sales and promotion of the DVD "The Arthur Collins Legacy A Culture of Innovation"

2. AACLA Publications

 Working toward E-Book publishing and sale of "Arthur Collins - Radio Wizard" on the AACLA web site: https://www.arthurcollins.org/. AACLA had earlier acquired publishing rights to this book.

3. Collins Historical Exhibits

- AACLA is conducting discussions with Rockwell Collins leadership on defining a future center and cooperative operating arrangements.
- Arthur Collins 1920s Attic Ham Station We received permission to do a three-dimensional laser scan of this room by the current owner of 514 Fairview Dr., Cedar Rapids. The room and house exterior was also extensively photographed. This documentation will enable construction of a replica for future planned exhibits.
- AACLA has drafted a specification for a mobile museum and is discussing possible configurations and requirements with the local school districts. This is a continuing effort to promote STEM educational opportunities tied to Collins history.

4. Artifact Collection and Preservation

- The AACLA collection of artifacts and documentation was moved from the two units at Cedar Storage Southeast into protected storage at Rockwell Collins (Building 134).
 Rockwell Collins is donating this climate controlled storage to the AACLA resulting in elimination of rental costs at our previous commercial facility.
- Media and digitized documents are stored on a series of high capacity portable computer hard drives. Working copies are kept by the Secretary while back-up copies are kept in a safe deposit box at the Collins Credit Union under the name of Terry Lamb, AACLA President.
- Throughout the year we continue to receive artifacts and donations significant to the history and Legacy of Collins. Of particular note were donations of:
 - Arthur Collins' 1926 ham station HF receiver, his General Radio Frequency Meter, and replica of his 1925 breadboard transmitter
 - KWM-2 and KWM-380 Amateur Transceivers
 - Collins advertising and historical films and 16mm projector

5. Public Events and Presentations

- AACLA Board Members regularly present 1 hour programs on Collins History to Rockwell Collins Employees at the History Community of Practice Events. The History CoP has consistently large attendance plus live streaming on the R-Web.
- Assisted the Rockwell Collins Museum Club in celebrating the 40th anniversary of GPS.

6. AACLA Development (Funding)

- A designated board member is leading the effort of writing grant proposals
- One grant proposal submitted and two more in process

Fiscal Year 2017 Financial Report

The AACLA fiscal year runs from Oct. 1, 2016 to Sept. 30, 2017. During this period the AACLA received revenue of \$27,695.88 of which \$25,855.00 was direct public support. We incurred expenses of \$18,308.42, of which \$15,111.78 was for video interviews. We ended the year with a net income of \$9,387.46.

A significant expense for storage facility rental was avoided mid-year when Rockwell-Collins agreed to store AACLA artifacts in a company secured facility. Sales of the DVD documentary "The Arthur Collins Legacy – A Culture of Innovation" provided nearly \$600 of income.
